EFFECT OF OVEREXPOSURE :

INHALATION

Acute: Copper sulphate may irritate the nasal passage and throat. Nasal ulceration may result from trace quantities of the impurity mainly sulphuric acid.

Chronic: Copper sulphate may result a condition resulting in lung and liver tumours (*vineyard sprayer's lung*)

SKIN AND EYES

Copper sulphate is corrosive to the eyes and may cause local inflammation, necrosis, an opaque cornea and adhesion of the eyelids. It may cause a light, localised, irritation of the skin.

INGESTION

Copper sulphate causes a sensation of burning in the throat, causes repetitive vomiting and leaves a metallic taste in the mouth. Intake of a large amount results in diarrhea and ulceration of the gastrointestinal tract.

MEDICAL CONDITIONS AGGRAVATED BY EXPOSURE

Persons with pre-existing skin disorders, impaired liver, kidney or pulmonary dysfunction, glucose-6-phosphate dehydrogenase deficiency or pre-existing Wilson's disease may be more susceptible to the effects of this material.
